MorseLife provides unrestricted, tribute and designated giving as part of our Annual Giving Society. example, to address the unique needs of Parkinson's patients, we recently received a generous gift to establish the Chair of Parkinson's Therapy at MorseLife.

MorseLife will be building a 10,000-square-foot Hospice on our campus. We are a teaching Hospice and one of the few Jewish Hospices, currently providing end-of-life and Palliative services in private homes. Although based on the principles of Judaism, we care for people of all faiths.

One of the many things that are unique to our Hospice is our Rest Assured program. This program assures that no patient will die alone. A Certified Nurse is assigned to each patient when a family member can't be there so they have someone with them 24 hours a day.

We are especially proud of our ability to help donors plan the most efficient and effective ways to give. We are pleased to work with them and their professional advisors to achieve their charitable, financial and personal goals.

WHAT IS THE "COVID-19 EMERGENCY RELIEF FUND" CAMPAIGN AND WHAT NEW CAMPAIGNS THAT SUPPORT THE FOUNDATION ARE ON THE HORIZON? Carolyn Rose, Vice President

The COVID-19 Pandemic and the safety precautions it requires for our most frail populations have had a significant impact on MorseLife. We are spending nearly \$400,000 per month on COVID-19 expenses, that's almost \$5 million in unanticipated expenses to date this year. We project up to

\$10 million in total losses over the next two years due to the pandemic. MorseLife continues to need the support of our community.

We are preparing to launch a Legacy Initiative for the MorseLife Health System. A simple bequest in a will helps ensure the future of the organization and does not cost any money today!
